




Total Crimes in India (2017-2021)






Crimes Against Children (2017-2021)



As proportion to total crimes in India, Crimes Against Children decreased from 2.58% in 2017 to 2.45% in 2021.

Crimes By Children In Conflict With the Law (2017-2021)



As proportion to the total crimes in India, Crimes by children in conflict with the law decreased from 0.67% in 2017 to 0.51% in 2021.













Child Victims of Kidnapping & Abduction in 2017



Child Victims of Kidnapping & Abduction in 2021




During the period of five years i.e. from 2017 to 2021, while there is 15.79% rise in crimes against children, the cases of kidnapping and abduction of children have also been on the rise.


A further analysis shows that maximum children are kidnapped/abducted in the age group of 16-18 years. The situation remains the same between 2017 and 2021. (see next slide...)


- A further look at the purpose-wise cases of kidnapping and abduction of children reveals that there is 21.88% rise in kidnapping of children for the purpose of MARRIAGE between 2017 to 2021.
- Similarly, a significant 70.88% increase is noted in the incidences of MISSING DEEMED AS KIDNAPPED children during this period.
- While there is a growing concern over the cases of romantic relationship being prosecuted under the POCSO Act, there is 32.85% increase in the cases of ELOPEMENT/LOVE RELATIONSHIP during 2017-2021.

- Some of the larger States/UTs continue to observe higher rates of incidents of Kidnapping & Abduction of Children over the years.
- Incidentally, these are also the States/UTs with maximum number of crimes against children.
- Some of these States/UTs also show high rate of pendency of crimes against children either at police station level or at courts or both.
